Changes Coming for Nonresident Big Game Licenses in Montana

On November 2, 2010, Montana voters passed Montana Hunter Access Funding Initiative No. 161, also known as I-161 with 58.8 % of the vote. I-161 revises the laws related to nonresident big game and deer hunting licenses. It abolishes the 5,500 outfitter-sponsored nonresident big game licenses (nonresident guaranteed tags) and places them in the nonresident general draw. The initiative also increases the nonresident big game combination license fee from \$628 to \$897 and the nonresident deer



combination license fee from \$328 to \$527. The initiative allocates a share of the proceeds from these nonresident hunting license fees to provide hunting access and preserve and restore habitat. I-161 is expected to increase state revenues over the next four years by an estimated \$700,000 annually for hunting access and an estimated \$1.5 million annually for habitat preservation and restoration, assuming that all nonresident hunting licenses are sold.

For those who have been following Initiative 161, you realize it is a controversial topic and has an impact that has yet to be determined. Increasing revenue for the state and programs like Block Management, increasing access to public lands and the affect on the Montana outfitting industry are highly debated. What we do know is that for Montana landowners who have a main residence in another state, the ability to secure an elk license has been affected. In Montana, a nonresident hunter wanting to hunt on private lands must contract with a licensed Montana outfitter and secure a guaranteed outfitter-sponsored nonresident licenses. In 2010 a nonresident outfitter sponsored elk combination fee was \$995. A nonresident hunter wanting to hunt on public lands would enter the general draw for one of the 11,500 deer and elk license. Now, hunters will not be guaranteed elk tags through an outfitter, to hunt their own property. I-161 requires hunters to enter the general nonresident draw process. The total number of nonresident big game licenses will increase from 11,500 to 17,000 in 2011 and the fee of \$897 is less than the old outfitter-sponsored license.

It should be noted that newly elected Rep. Bill Harris, R-Mosby, has requested the drafting of a bill to rescind the measure (I-161). We will follow this and provide information as warranted. 
